Ikon AVS Software License Agreement

These Terms apply to any of the software developed by Ikon AVS and Nebula Audio Ltd.

BY DOWNLOADING AND/OR USING SOFTWARE FROM IKON AVS, THE INDIVIDUAL OR ENTITY LICENSING THE PRODUCT ("LICENSEE") IS CONSENTING TO BE BOUND BY AND IS BECOMING A PARTY TO THIS AGREEMENT. IF LICENSEE DOES NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, THE LICENSEE MUST NOT INSTALL OR USE ANY OF THE SOFTWARE DEVELOPED BY IKON AVS.

LICENSE TERMS

Ikon AVS hereby grants the Licensee and the Licensee accepts a nonexclusive, non-transferrable license to use the Software provided by Ikon AVS.

The Software is designed as a software development and customisation tool. As such Ikon AVS cannot and does not guarantee any results of use of the Software or that the Software will operate error free and the Licensee acknowledges that any development that they perform using the Software or Host Application is done entirely at their own risk.

The Software is licensed and not sold. Ikon AVS retains ownership of the Software and all copies of the Software and reserves all rights not expressly granted in writing.

2. OTHER LIMITATIONS

Except as otherwise expressly permitted in this Agreement, or in another Ikon AVS agreement to which Licensee is a party such as a distribution agreement, Licensee may not: (i) decompile, disassemble, reverse engineer, or otherwise attempt to derive the source code for the Product (except to the extent applicable laws specifically prohibit such restriction); (ii) redistribute, encumber, sell, rent, lease, sublicense, or otherwise transfer rights to the Product; (iii) remove or alter any trademark, logo, copyright or other proprietary notices, legends, symbols or labels in the Product.

TERMINATION

Without prejudice to any other rights, Ikon AVS may terminate this Agreement immediately upon notice if the Licensee fails to comply with the terms and conditions of this Agreement. In such event, you must destroy all copies of the Software and all of its component parts.

4. PROPRIETARY RIGHTS

Title, ownership rights, and intellectual property rights in the Product shall remain in Ikon AVS. Licensee acknowledges such ownership and intellectual property rights and will not take any action to jeopardize, limit or interfere in any manner with Ikon AVS' ownership of or rights with respect to the Product. The Product is protected by copyright and other intellectual property laws and by international treaties. Title and related rights in the content accessed through the Product is the property of the applicable content owner and is protected by applicable law. The License granted under this Agreement gives Licensee no rights to such content.

IKON AVS LIMITED WARRANTY

The product is provided free of charge, and, therefore, on an "as is" basis, without warranty of any kind, including without limitation the warranties that it is free of defects, merchantable, fit for a particular purpose or non-infringing. The entire risk as to the quality and performance of the product is borne by licensee. Should the product prove defective in any respect, licensee and not Ikon AVS or its suppliers assumes the entire cost of any service and repair. This disclaimer of warranty constitutes an essential part of this agreement. No use of the product is authorised hereunder except under this disclaimer.

IKON AVS shall not be liable to honour warranty terms if the product has been used in any application other than that for which it was intended, or if it as been subjected to misuse, accidental damage, modification, or improper installation procedures.

ANY LIABILITY OF IKON AVS FOR A DEFECTIVE COPY OF THE SOFTWARE WILL BE LIMITED EXCLUSIVELY TO REPAIR OR REPLACEMENT OF YOUR COPY OF THE SOFTWARE WITH ANOTHER COPY. THIS WARRANTY SHALL BE THE SOLE AND EXCLUSIVE REMEDY TO YOU. IN NO EVENT SHALL IKON AVS BE LIABLE FOR INCIDENTAL, CONSEQUENTIAL, SPECIAL OR PUNITIVE DAMAGES OF ANY KIND (PROPERTY OR ECONOMIC DAMAGES INCLUSIVE), EVEN IF AN IKON AVS REPRESENTATIVE HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES OR OF ANY CLAIM BY ANY THIRD PARTY. IKON AVS MAKES NO WARRANTIES, EXPRESS OR IMPLIED, AS TO TITLE OR INFRINGEMENT OF THIRD-PARTY RIGHTS, MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE, OR ANY OTHER WARRANTIES, NOR AUTHORISES ANY OTHER PARTY TO OFFER ANY WARRANTIES, INCLUDING WARRANTIES OF MERCHANTABILITY FOR THIS PRODUCT.

HIGH RISK ACTIVITIES
